



# Project Title: "Revaluating RURal areas in Europe through the development of social farming ACTivities"

Project acronym: RURACT Reference number: 549385

Duration: 24 months (01/01/2014-31/12/2015)

General description of the project: The Molise Region is characterized by many municipalities with a high percentage of rural areas where the development of rural activities is strongly limited by geomorphologic and climate factors, weaknesses of the socio-economic environment, great distance from markets and major centres, limited access to credits, high territorial fragmentation, lack of technological equipments and facilities. In the framework of the local integrated development strategy of the Molise Region and of the projects for internal areas (PIT), whose intent is the generation of "manufacturing hub" and sustainable opportunities of employment and development; the overall objective of the project is the creation of a network of towns to implement social, cultural and economic synergies, to better face common challenges related to the revaluation of rural areas through the development of social farming businesses as a criteria of sustainability and solidarity. Specific objectives of RURACT are: make social farming as a strategy to improve the competitiveness among business and rural areas; raise awareness about European policies and opportunities in the field of social inclusion and social protection; create a new sense of development, social protection and environmental preservation in rural areas; improve the condition so that disadvantaged people with low contract capacities can give a sense to their capabilities through the agricultural activities; create an ideal framework for the development of future collaborative actions. Specifically, the project will promote joint initiatives to involve policy makers, public officials, schools, youth and older people's organizations, local and regional authorities; voluntary associations, university departments, public and private health bodies, agriculture organizations in exchange of experiences, best practices and in concrete opportunities of reflection on possible future shared activities through conferences, seminars, workshops, study visits.
